

# SPECIAL CONTEST RULES FOR ENTERING

## PLEASE READ AND FOLLOW THESE RULES CAREFULLY

1. **WHERE NEEDED, ENTRIES MUST BE PREREGISTERED** by mail, before Saturday, August 15, 2009.  
**NOT ALL ENTRIES IN DEPT. 20 NEED TO PREREGISTER.**
2. Carefully read the **RULES FOR ENTERING** listed in each class of the **Special Contests** and follow the rules for the class you are entering.  
You **WILL NOT RECEIVE A TICKET** to enter the Fairgrounds. All contests are live, you can walk up and register unless otherwise stated in that contest's rules for entering.
3. **PREREGISTERING** will guarantee you a place in the contest you choose, nothing else.  
**Getting to the contest is your responsibility not ours.**
4. **ONLY ONE PERSON PER FORM.** No changes or additions will be allowed.
5. You **MUST** enter your items on the **PROPER ENTRY FORM.** Only **ONE ENTRY PER LINE.**
6. You **MUST** list the **CLASS LETTER** and **LOT NUMBER** for **EACH ITEM** you enter.

8. Bring **ALL ENTRIES** to the Fairgrounds on **the RIGHT RECEIVING DAYS:**  
**The Great American Spam Championship, Friday - Fleischmann's Yeast Bakers Unite For A Cause Contest, and The Kids Karo Cookie Contest, Saturday - Ghirardelli Chocolate Championship Contest, Sunday.**  
The Coloring Contest may be brought or sent to the Woodstock Fair office anytime before Wednesday, August 27, 2009. Coloring pages may be obtained at the Fair office, So. Woodstock Post office or at [www.woodstockfair.com](http://www.woodstockfair.com).  
  
**ALL OTHER CONTEST ARE PEOPLE CONTEST.** Please arrive at the **South Stage Family Fun Center**, 10 minutes before your contest begins to sign in.  
**REMEMBER:** All Special Contests are held "**LIVE**" at the Woodstock Fair South Stage - Family Fun Center Tent.
9. When Judges have made their decisions, the Superintendents will see that awards are properly distributed.  
First Premium, **BLUE**; Second Premium, **RED**; Third Premium, **WHITE**. All premium money will be paid from the **JUDGING SHEETS** and **NOT** from any ribbons that may be attached to the exhibits.  
**ALL JUDGING RESULTS ARE FINAL. PREMIUMS WILL BE PAID BY MAIL, BEFORE SEPTEMBER 30, 2009.**
10. While the Society gives due supervision to its halls and grounds during the Fair, it does not hold itself liable or responsible for the loss of the property of exhibitors through damage or theft.
11. **ALL ENTRIES MUST** be removed at **DESIGNATED TIMES ONLY:**  
Monday 7:00 PM to 8:00 PM and Tuesday 8:00 AM to 9:00 AM.
12. Unless other arrangements are made any article not removed by 9:00 AM on Tuesday will become the property of the Woodstock Fair and will be disposed of accordingly.
13. All premiums, for all departments, will be forfeited if any item or animal is removed from grounds before designated times.
14. To insure proper handling of **YOUR ENTRY** please follow **ALL THESE RULES.**  
**A copy of your accepted entry form will be returned to you. If not received by August 28, please call the Fair Office at 928-3246, ext. 104. If needed, call for information on any other departments.**
