

LIVESTOCK RULES FOR ENTERING

PLEASE READ AND FOLLOW THESE RULES CAREFULLY

1. **EVERY ANIMAL MUST be PREREGISTERED** by mail, before **Saturday, August 14, 2010**. No phone entries please. **NO EXCEPTIONS**. All entries **MUST be PREREGISTERED**. **NO** additions or changes will be allowed once form is received by the Entry Superintendent.
2. You **MUST** call Department Superintendents (**EXCEPT THE SHEEP DEPARTMENT**) to reserve your barnspace for the number of animals you intend to bring. If for any reason you cannot attend after preregistering, you **MUST** notify the Superintendent of that department in order to be eligible for the following year.
3. **NO BOARDING FEE FOR ANY ANIMAL. NO BOARDING FEES in YOUTH SHOWS. BIRTH CERTIFICATE or PROOF OF AGE REQUIRED FOR ALL YOUTHS** entering Youth Shows.
4. **SEND ENTRY FORMS TO:** The Superintendent of Entries, Joy Blackmar, P. O. Box 1, So. Woodstock, CT, 06267. FAX 860-963-7499. **DEADLINE:** Saturday, August, 14, 2010.
5. Send **Lead Line summaries** to the Superintendent of Entries **with entry form**, when entering that class **NO EXCEPTIONS**.
6. **ONLY ONE PERSON PER FORM**. You **MUST** list the **DEPARTMENT NUMBER, CLASS LETTER** and **LOT NUMBER** for **EACH ANIMAL** you enter. Consult the proper livestock pages and be careful when selecting Department number, Class letter and Lot number.
7. You **MUST** enter your animals on the **PROPER ENTRY FORM**. Only **ONE ANIMAL** per line (unless a group lot). **NO HORNED CATTLE** will be allowed to enter the fair. **NO SCURS** over 1-1/2 inches long.
8. Bring **ALL PREREGISTERED ANIMALS** to the fairgrounds on **RECEIVING DAY**, Thursday, Sept. 2nd, between 10:00 AM and 7:00 PM, **unless otherwise stated**.
9. No stock will be allowed to run at large on the fairgrounds. Wash animals in designated areas only.
10. **ALL EXHIBITORS AND THEIR HELP ARE REQUIRED TO WEAR SHIRTS AND SHOES AT ALL TIMES.**
11. All exhibitors of livestock or their agents are required to bring their animal into the ring to be judged when called for by the Superintendent. Those failing to comply will be barred from competition.
12. When Judges have made their decisions, the Superintendents will see that awards are properly distributed. First premium, **BLUE**; second premium, **RED**; third premium, **WHITE**. All premium money will be paid from the **JUDGING SHEETS** and **NOT** from any ribbons that may be attached to the animals. **ALL JUDGING RESULTS ARE FINAL. PREMIUMS WILL BE PAID BY MAIL, BEFORE SEPTEMBER 30, 2010.**
13. **ALL ANIMALS MUST** be removed at **DESIGNATED TIMES ONLY**. Check department pages for proper times. All premiums, for all departments, will be forfeited if any animal leaves the Fair before designated times.
14. All exhibitors **MUST COMPLY** with the State of Connecticut, Department of Agriculture's 2010 Connecticut Fair and Show requirements as well as the Woodstock Fair Rules for entering livestock. **NO EXCEPTIONS**. To insure proper handling of **YOUR ENTRY** please follow **ALL RULES. PREREGISTER EARLY**.

A copy of your accepted entry form will be returned to you. If not received by August 21st, please call the Fair Entry Office at 928-3246, ext. 104. Call with corrections as soon as possible.
