**Camping Rules**

- Campers must arrive between the hours of 8:00 a.m. and 8:00 p.m.
- Concessionaires must arrive by 8:00 PM on Thursday, Aug. 31, 2017.
- Campers must leave the camping area by **Tuesday, September 5, 2017 no later than 6 pm; no exceptions.**
- Each campsite includes parking for an RV/Camper and one vehicle, space permitting. Parking for additional vehicles is available for \$5.00 per day. Tent fees are in addition to vehicle parking fee.
- Camping fee does not include admission to the main Fairgrounds.
- **Utility Information**
  - Water and electrical hook-up allowed only in campsites approved by the Fair Parking Department.
  - Each site is provided with one 20 amp 120 volt ground fault receptacle. There are no provisions for 30 or 50 amp service.
  - Use of an air conditioning unit is prohibited.
  - Generators must be turned off at 9 PM. Quiet hours are 10:00 pm – 8:00 am.
  - **Any tampering with Woodstock Fair electrical equipment will result in immediate removal from the fairgrounds.**
  - A backflow device is required on all connections to the Fair water supply.
  - Dumping of gray water is prohibited. Campers are allowed a one-time use of the dumping station located by the North Gate. Use of this station will require a 10' hose.
- Parking in fire lanes is prohibited; vehicles will be towed at the owner's expense. All fire lanes will be strictly enforced.
- Do not remove fire lane or lot # signs. **Missing or damaged signs will be charged to site occupant.**
- Alcohol, firearms and/or weapons of any kind are **not** allowed on the Woodstock Fair Property.
- Open fire pits and bonfires are prohibited.
- Please keep camping site clear of trash; trash receptacles are available on the grounds.
- **Pets are restricted to the confines of the campsite and must be securely tied, penned or fenced. Pets must be leashed at all times and are not allowed on the Main Fairgrounds or the Horse Show Grounds. The pet owner assumes all responsibility and agrees to release and/or indemnify the Woodstock Agricultural Society, Inc. from any and all claims related to loss, damages, and personal injury including death.**

The Woodstock Agricultural Society, Inc., and its authorized personnel reserve the right, in their sole discretion, to accept, exclude, reject, relocate or remove the Camper from the fairgrounds and parking areas for any reason including any Camper who breaches the terms of this agreement, or any of the rules stated herein. Violations shall be cause for the immediate revocation and forfeiture of all privileges herein granted. Any and all sums, paid or contracted to be paid under this agreement to the Woodstock Agricultural Society, Inc., shall be forfeited and become the property of the Woodstock Agricultural Society, Inc. as liquidated damages for said breach of agreement. The Camper acknowledges that this provision is essential to maintain the intent, character and safety of others of the Woodstock Fair. The Camper therefore waives any claim for damage against the Woodstock Agricultural Society, Inc., Woodstock Fair, and its officers, agents and representatives for the good faith enforcement of this provision.

**Indemnification:** Except for claims resulting solely from the negligent acts or omissions of the Society, the Camper shall indemnify and hold the Woodstock Agricultural Society, Inc., harmless against and free from any and all liabilities, fines, suits, claims, demands, actions and costs, and reasonable expenses of any kind or nature, including, but not limited to, reasonable attorneys fees, made by anyone whomsoever, due to, or arising out of:

- Any default in observing, violation or nonperformance of any term, covenant or condition of this Agreement on the part of the Camper to be observed and performed; or
- Any damage to any person or property occasioned by the Camper's use and occupancy of the facilities, or to any use or occupancy which the Camper may permit or suffer to be made of the facilities; or
- Any injury to any person or persons, including death, resulting at any time therefrom occurring in or about the fairgrounds.

The Camper agrees to comply with all applicable federal, state, and municipal laws, including those set forth by the Woodstock Agricultural Society, Inc. and amended from time to time.
